- 3) The quotation submitted shall remain valid at least 90 days. from the date of opening the quotation .
- 4) The rate should be inclusive all taxes , transportation etc. (as per our Price bid format) . Nothing extra will be paid in addition to the quoted rate . Price should quoted in Indian Rupee.
- 5) In the event of date being declared a closed holiday for purchaser’s office, the due date for submission of quotation & its opening will be the following working day at the appointed time .
