- c)** The quotation submitted shall remain valid at least 90 days from the date of opening the quotation .
- d)** The rate should be inclusive all taxes, transportation etc. (as per our Price bid format) . Nothing extra will be paid in addition to the quoted rate. Price should quote in Indian Rupee.
