The technical bids will be opened first to judge/evaluate the technical specifications of the said *instrument* and thereafter the price bids of only technically qualified bidders will be opened.

Please note that IACS will not provide any accommodation or reimburse any expenses to any of the bidders for attending opening of technical bid.

1. TECHNICAL BID

The technical bid should contain technical specifications and should be kept in a separate sealed envelope duly super scribed as 'TECHNICAL BID' on the outer cover of the envelop.

Service Facility: Supplier should mention the details of their service setup and man powers in India, preferably Kolkata.

2. PRICE BID

The financial bid indicating the price (including the warranty) for the item(s) mentioned in the technical bid should be kept in a separate sealed envelope duly superscribed as 'PRICE BID' on the outer cover.

PRICE: Price to be quoted on door delivery at IACS. Price of the equipment to be quoted in INR only.

3. BID SECURITY:

- a. An Account payee Demand Draft/Pay Order/BG (Bank Gurantee) of any Commercial Bank for **Rs. 11,000/-** (Eleven Thousand Rupees only) drawn in favour of "Indian Association for the Cultivation of Science (State Bank of India, Jadavpur University Branch, A/C No. 11079699211, IFSC: SBIN000093, MICR Code: 700002048)" is to be furnished by the bidders except those who are registered with Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organisation or the concerned Ministry or Department
- b. The Bid-Security should have at least 90 (ninety) days validity from the last date of submission of the bid.
- c. In case of non-award of the work the Bid Security money would be returned to the unsuccessful Bidders.

4. PERFORMANCE SECURITY:

An Account Payee Demand Draft/Pay Order/BG of Rs. 25,000/- on any Commercial Bank in the name of "Indian Association for the Cultivation of Science" is to be furnished by the successful bidder as Performance security. Performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. The Bid security or EMD would be refunded to successful bidder on receipt of the Performance security.

GENERAL INSTRUCTIONS

1. Validity of tender: Tender submitted should remain valid for at least six months from the date of opening the tender. Validity beyond six months from the date of opening of the tender shall be lapsed by mutual consent.
2. Incomplete and conditional tenders as well as tenders received after the due date will be summarily rejected without assigning any reasons thereof.
3. Payments: 100% against delivery and successful installation subject to submission of performance guarantee.
4. Installation/Demonstration/Application training at site: Installation & user training at IACS, free of cost by the supplier.
5. Service facility: In India, preferably Kolkata, supplier should mention their details of service setup and man powers who are responsible for after sales support. Response time should be within 24 hrs.
6. Proposed delivery schedule should be mentioned clearly.
7. Manufacturers / exclusive distributors / vendors should have history of supplying this type of instruments to this or other scientific organizations. Availability of a list in this regard would be preferred.
8. Authorized dealership certificate should be provided in case of principal manufacturing company is not quoting directly.
9. Guarantee certificate, users manuals etc. are to be handed over to the user after successful commissioning of the system.
10. In the event of date being declared a closed holiday for the purchaser's office, the due date for submission of bids and opening of the technical bids will be the following working day at the appointed time.
11. In case of any dispute, the decision of IACS authority shall be final and bidding on the bidders.
