Sealed tender in single bid system is invited among Service provider / dealer of M/s Blue Star Ltd. , having marketing and servicing establishment in Kolkata , to carry out the following job at IACS, Jadavpur , Kolkata - 32. The bidder must have knowledge of similar type /capacity of ACs dismantling and re-commissioning work to Government Organization / Government Research Institute or Highly Reputed Private Organization for Industrial / Research Application etc. during the last 5 years (details of work is given below) reckoned from the date of issue of this tender / NIT notice .Therefore, interested parties may please send the offer ("Technical Bid" & "Financial bid") in a sealed envelopes to the Receiving & Despatch Section of IACS, Jadavpur on or before 8/06/2026. (up to 3 p . m .) mentioning the NIT No. & due date on the top of the envelope. The bids will be opened on 08/06/2026 i.e. the same day at 4.30 p.m. in presence of the intending bidders. . If holiday is declared on the schedule date of opening, the tender will be opened on the next working day at 4.30 P.M. The Technical bid shall contain the credential to fulfil the eligibility criterion as asked for in this purchase enquiry notice, earnest money deposit (EMD), VAT/GST registration certificate, PAN, Dealership Certificat i.e. an authorisation letter of M/s Blue Star Ltd. i.e. Original equipment manufacturer to be submitted along with the bid documents to participate in this tender , client list, etc. with this tender document duly filled in all respect and properly signed & sealed in all pages and any other documents considered to be essential to establish their credibility EXCEPT THE PRICED OFFER.. The sealed envelopes should reach the Registrar, IACS, Jadavpur, Kolkata 700032 on or before 08/06/2026 (upto 3 p.m.) . The down loaded tender document should be submitted with bid along with a Bank Draft./Bankers cheque of Rs. 526/- (500/- + 5% GST = Rs.526/ -, CGST & SGST@ Rs.12.50 rounded to Rs.13.00 each) , as a Tender paper cost (non refundable) .

The total estimated cost = Rs. 410616/- (including 18% GST) . The estimated cost however, is mentioned as rough guideline.

Name of the Work : Dismantling and re-commissioning of 12 nos. 10 HP outdoor units connected to 6 nos. 20 HP Inverter type Floor Mounted Package ACs (Blue star Make ACs)

Eligibility Criteria : The minimum eligibility criteria for the contractors / bidders will be as follows:

A) Completion of one similar work of value not less than 80% of the estimated cost put to tender under Government, Semi - Government , PSU, Govt. funded Autonomous Body or large corporate organization of repute , in the last 5 (seven) years to be reckoned from the date of issue of NIT

B) Completion of two similar works each of value not less than 60% of the estimated cost put to tender under Government, Semi - Government, PSU, Govt. funded Autonomous Body or large corporate organization of repute , in last 6 (seven) years to be reckoned from the date of issue of NIT.

OR

(C) Completion of three similar works each of value not less than 40% of the estimated cost put to tender under Government, Semi - Government, PSU, Govt. funded Autonomous Body or large corporate organization of repute , in last 7 (seven) years to be reckoned from the date of issue of NIT.

d) Similar work shall means same type dismantling and re-commissioning of 12 nos. outdoor units connected to 6 nos. 20 HP Inverter type Floor Mounted Package ACs (Blue star Make ACs).

Terms& Conditions :

1) Cost of Tender Form: The intending bidders may submit the tender documents, downloaded from our Website (www.iacs.res.in), against a payment of Rs.526/- (Rs. 500/- + 5% GST = Rs.526/- , CGST & SGST@ Rs.12.50 rounded to Rs.13.00 each) ,per Set(Non refundable), of a Scheduled Bank .The cost of tender should be sent in a separate envelope , along with the "Tender documents" . Tender paper, submitted without the Cost of tender shall be summarily rejected.

2) An authorisation letter of M/s Blue Star Ltd. i.e. Original equipment manufacturer to be submitted along with the bid documents to participate in this tender.

3) The contractor should have a valid Dealership Certificate of M/S Blue Star Ltd , PAN/TAN Number/ESI Registration /Sales Tax/Service Tax/GST Registration Numbers/ valid Labour Contract License with the Central /State Government and details thereof should be provided.

4) The contractor/Service Provider shall comply with all provisions of Govt. labour laws and other statutory requirements in relations to the persons /Technicians engaged in the Work , including payment of minimum wages. IACS shall not be responsible for this purpose .

5) The offer / BID should be valid for minimum 60 days for acceptance of the same. **The quoted rate should be inclusive of all taxes, delivery charges etc.** Nothing extra will be paid except to the accepted rate.

6) Payment terms : Payment will be made within 45 days from the date of submission of bill .

7) Bill should submitted after completion of job as per work Order .

8) EMD : EMD of Rs.12318 /-(3% of the estimated cost) to be enclosed with the quotation (i.e. with Technical bid and Financial bid) in favour to "Indian Association for the Cultivation of Science" through pay order/ demand draft on local Bank which will be released to the unsuccessful bidders on demand after issuing of the Work Order / Purchase Order to the successfully bidder . The EMD will be released to the successful bidder on demand after receiving full security deposit (i.e. 10% of the order value) from the invoice / bill of successful bidder .The EMD shall not carry any interest.

9) Security Deposit : @10% of the total Order value will be deducted from the invoice of the successful bidder as Security Deposit and it will be released after 6 months from the date of completion of Work subject to successfully completion of Work as per work order . Security deposit shall not carry any interest. Further ,

the Security Deposit will be refunded to the successful bidder after getting approval of the competent authority of IACS. Also, the successful bidder will have to submit a letter to get back their Security Deposit .

(10) The bid must carry the signature (with company seal) of authorized signatory of the Company /firm on each page of this purchase enquiry/tender document along with other documents as asked for to be submitted with their bid.

(11) The EMD will be forfeited if the successful bidder fail to provide service as per Work Order .

12) Complete Purchase Enquiry Document will be available at www.iacs.res.in / Tender and the same should be downloaded from IACS website for submission . Conditional offer including conditional rebates shall be summarily rejected

13) The IACS authority reserves the right to reject any or all the offers without assigning any reason thereof.

14) The successful bidder should have servicing establishment at Kolkata (it is a must to qualify a bidder in the technical bid).

15) Bill should be submitted after successful Completion of work as per work order .

16) Authorized dealership certificate should be provided in case of Principal manufacturer is not participating directly/ bidding directly.

17) The E.M.D shall be forfeited if a bidder withdraws its bid during the period of bid validity and the supplier /vender will be banned from IACS from participating all types of tendering in future.

18) The tender documents should be down loaded from IACS website .

19) Rs. 526 /- non refundable Demand Draft/ Pay Order to be paid (with the technical bids) as a tender paper cost in favour of Indian Association for the Cultivation of Science payable at Kolkata from a scheduled Bank positively along with the tender/ quotation in a separate Envelope without which the tender will summarily be rejected.
