- b) The outer cover of the envelop should be super scribed as " Quotation for Supply & installation of SHURE make wireless Hand held Microphone with Base Station at Council Room (M. N. Saha Meeting Room) , Tender No. , last date of Submission , due date of opening etc.
- c) The quotation submitted shall remain valid at least 30 days. from the date of opening the quotation .
- d) The rate should be inclusive all taxes , transportation etc. (as per our Price bid format) . Nothing extra will be paid in addition to the quoted tate . Price should quoted in Indian Rupee.
- e) In the event of date being declared a closed holiday for purchaser's office , the due date for submission of quotation & its opening will be the following working day at the appointed time .
- f) Payment : Within 30 days from the date of bill submission.**
- g) Delivery time : 07 days from the date of receipt of Work Order.**
